

NOTICE OF PUBLIC HEARING CONCERNING THE ISSUANCE, FROM TIME TO TIME, BY THE HOUSING FINANCE AUTHORITY OF PALM BEACH COUNTY, FLORIDA, OF NOT EXCEEDING \$30,000,000 OF ITS MULTIFAMILY HOUSING REVENUE BONDS (LAKE WORTH TOWERS) TO BE ISSUED IN ONE OR MORE SERIES.

Notice is hereby given that on Friday, December 9, 2022, at 9:00 A.M., or as soon thereafter as possible, the Executive Director of the Housing Finance Authority of Palm Beach County, Florida (the "Authority"), will conduct a public hearing on behalf of the Authority for the purpose of giving interested persons an opportunity to be heard regarding the proposed issuance by the Authority of its Multifamily Housing Revenue Bonds (Lake Worth Towers) (herein the "Bonds"), in an aggregate principal amount of not exceeding \$30,000,000. The Bonds will be issued from time to time in one or more series to finance a loan (the "Loan") to be made by the Authority to Lake Worth Towers Preservation, L.P., a Florida limited partnership, or its successor or assign (herein, the "Borrower"). The proceeds from the Loan will be used by the Borrower to finance a portion of the costs of the acquisition, rehabilitation and equipping of an approximately 195 unit multifamily rental housing facility for the elderly known as "Lake Worth Towers" to be available for rental to qualified individuals of low, moderate and middle income (the "Project"). The Project is located at 1500 Lucerne Avenue, Lake Worth Beach, Florida 33460. The initial owner or manager of the Project will be the Borrower.

The Bonds will mature not later than forty (40) years from their date of issuance and will be payable from the revenues of the Project and/or such other collateral as shall be acceptable to the Authority.

The Bonds will not constitute an indebtedness of the Authority, Palm Beach County, Florida, the State of Florida (the "State") or any other political subdivision of the State within the meaning of any constitutional or statutory debt limitation or restriction. The Authority has no taxing power.

The public hearing will be held at Palm Beach County Airport Center Complex, 100 Australian Avenue, West Palm Beach, Florida 33406, 4th Floor Room 4-790. At such public hearing, persons will be given an opportunity to express their views, both orally and through written statements which are submitted to the Authority on or before the public hearing.

Persons wishing to express their views or questions through written statements may do so by submitting them on or before the public hearing to: David M. Should any person decide to appeal any decision made by the Authority, he or she will need a record of the proceedings and may need to ensure that a verbatim record of the proceedings is made, which record must include testimony and evidence upon which the appeals may be based.
